Essential and Supplemental Functions

- 1. Track and review data utilizing various software systems to examine law enforcement reporting data on individuals identified through AFIS and CODIS parameters.
- 2. Identify cases that require further investigation and disseminate to appropriate and relevant staff.
- 3. Monitor crime trends related to AFIS reporting.
- 4. Compile case packets for detectives and forwards them to the appropriate investigative unit for follow-up.
- 5. Audit and review victim profiles to determine if further examination or investigation is warranted; reduces instances where a victim profile was misidentified as requiring further examination or investigation.
- 6. Identify offenders with multiple cases; communicate with field officers and appropriate personnel to ensure timely investigation.
- 7. Coordinate and work with investigations personnel to ensure the proper preparation of evidence for court, departmental hearings, and review boards.

SUPPLEMENTAL FUNCTIONS:

- 1. Attend and participate in professional group meetings; stay abreast of new trends and innovations in the field of law.
- 2. Perform other related duties and responsibilities as required.
